

Chennai data center capacity is expected to grow by 2.5 times to 133 MW by 2023 owing to demand from cloud players as per a JLL report titled '2020 India Data Center Market Update'.

Siva Krishnan, Managing Director - Chennai & Coimbatore, JLL India, said, "Chennai is expected to remain as leading data center destination due to its strategic location, four cable landings and reliable power supply. The city witnessed 16 MW absorption in 2020 primarily driven by demand from cloud players. The key data center hubs of Ambattur and Siruseri are expected to add 79 MW during 2021-23. Cloud players are expected to prefer high quality, scalable data centers facilities offered by the operators.
